## 新加坡福建会馆属校学生助学金申请 APPLICATION OF BURSARY FOR SHHK AFFILIATED SCHOOLS STUDENTS

### 申请须知与条款

- 1. 凡新加坡福建会馆属校在籍学生, 皆可提出申请。申请者须附上有关家庭经济状况的证明文件。
- 2. 所有申请书皆须由校长推荐方为助学金审查委员会接受。
- 3. 申请者的每个月家庭人均收入不超过\$800或每个月家庭总收入不超过\$3,000。
- 4. 学生的平均学业成绩须在50分以上,学校出席率必须维持90%以上。
- 5. 本助学金共分 2 组: 小学组\$500, 中学组\$700。
- 6. 本助学金每年颁发一次,有需要者,翌年可继续申请。
- 7. 凡已获得其它机构助学金之学生,其申请将不被接受,特殊个案,将视个案详情处理。
- 8. 本会馆可拒绝接受任何申请而无须说明理由。获得助学金者,若被发现填报不实,或因违反校规而被处分,其助学金将被取消。
- 9. 助学金之分发,将于审查委员会决定后,由校方个别分发给有关学生。

#### Terms and Conditions

- 1. Applications are opened to students of Singapore Hokkien Huay Kuan's affiliated schools. The applicant should submit all supporting documents together with this application.
- 2. Only application with the recommendation from the school principal will be considered.
- 3. The Household Per Capita Income should not exceed \$800 per month or Gross Household income should not exceed \$3,000 per month.
- 4. The applicant should attain an overall average result of at least 50% in respect of his academic work and must maintain at least 90% attendance in school.
- 5. This bursary comprises 2 sections: Primary Section -- \$500; Secondary Section -- \$700
- 6. Each bursary is granted on a year to year basis. Applicant can apply again the following year if the need arises.
- 7. Applicant must not be currently holding any scholarships and/or bursaries. However, exceptions may be considered on a case-by-case basis.
- 8. The Selection Committee shall have the right to reject any application without providing any reason. The bursary will be forfeited in the event any information provided herein is untrue or the applicant is subject to any disciplinary action.
- 9. The bursary will be disbursed to the successful applicant through the school and in such manner or mode as Singapore Hokkien Huay Kuan in its absolute discretion deem fit.
